RULES AND REGULATIONS

1. All forms must reach the Amazing Vista Walk Hunt Secretariat by the stipulated time and date to be entitled for participation at Redemption Counter, Low Yat.
2. Microsoft employees and participating media/agencies will not be eligible to participate in the Hunt.
3. A Team must be made up of minimum 3 persons, maximum 4 persons, including a Team Leader.
4. Participants must be of age 12 and above.
5. Entry forms must be fully completed, with the Declaration of Indemnity signed before it can be officially accepted as an entry.
6. Prizes will be awarded to the top scoring teams.
7. All materials of whatsoever nature in relation to the Hunt (whether submitted as a treasure in the Hunt or otherwise) shall belong to the Organizer and no participant shall be entitled to use such materials to publicize the Hunt in any form or for any purpose that the Organizer deems fit.
8. The decision of awarding prizes and points by the Judges will be final.
9. Participants are required to comply with the dress code for the Hunt as determined by the Organizer. Each participant will be given a Hunt t-shirt and this must be worn at all times throughout the Hunt. Failure to do so will lead to points being deducted from their score.
10. Participants are not allowed to use skates, skateboards, roller blades, bicycles, tricycles or motorized transport during the Hunt. Any team found doing so would be disqualified.
11. The onus of individual safety during the Hunt rests on each individual participant.
12. No other forms of advertising other than those of the official sponsors will be permitted during the event.
13. The organizer reserves the right without assigning any reason therefore to:-
 - a. Make any changes, abandon, cancel or postpone the Hunt as deemed necessary;
 - b. Reject any entry whether before or after the acceptance thereof;
 - c. Bar or exclude any one or more members from any team;
 - d. Disqualify and/or impose penalty points on any team found to have been guilty of (i) the breach of these Rules and Regulations and road traffic rules (ii) collaboration or cheating in any manner (iii) providing a false Declaration and (iv) failing to complete the Hunt within the stipulated time.
